of a crime". The feds also confiscated a printing press from the garage of two defendants, claiming that the Emma Goldman Book Club was the ideological arm of the "antifa cell". This outrageous criminalization of protected speech materials threatens the right to free expression and discourse, as well as the ability to circulate ideas of dissent in a dying empire bent on control.

#### Q. Any security tips for folks planning a protest against ICE or other federal entities?

Honestly, the usual things. Stay organized, wear black bloc, go in large groups, be very familiar with the area. There is no full proof way though to prevent repression, so it is crucial to move with principled relationships, with people you trust who honor the same higher love and liberation that you are fighting for. Self interest and self preservation must be sacrificed in the name of solidarity. Non-cooperation is a stance that must be deeply committed to beforehand, so that betrayal of each other and betrayal of the cause never happens. No amount of encryption matters when you're talking to a fed or someone hands the police their phone. Know your rights, stay silent but don't lie, request a lawyer.

#### Q. Is it possible to write letters to folks currently locked up?

Yes, please write letters. Our incarcerated comrades love them. We also have an updated list of their interests on our website:

#### Q. How can folks outside Texas support the defendants? What about besides donations?

The Prairieland Defendants could be facing many years incarcerated. Ordering care packages and sending commissary will be helpful through this time. Ordering books for defendants, though this may need to be coordinated with their support team due to book limits. Most urgently, we need people to show up and pack the courts for the upcoming trials beginning on February 17 (federal) and April 20 (Dario Sanchez). The fed trial, starting February 17, will likely be up to 5 weeks so we need people to come to town to show support through it. If you can't make it, teach about the Prairieland Defendants in your community. We will have educational materials on our website to help with this. Most of all, never forget the Prairieland Defendants or any political prisoner. These were real people with real lives and real communities, and they are deeply, deeply missed.

## Support Prairieland Defendants

### Q&A with the DFW Support Committee

*On July 4<sup>th</sup> a small group of a dozen folks held a noise demo to support immigrants locked up in the Prairieland Detention Center near Dallas/Fort Worth, TX. Now 18 community members, including six who weren't even at the protest in North Texas, are being charged with a broad range of heavy felony cases in a major federal test case for cracking down on "antifa." Sab Noise spoke with the DFW Support Committee about the case and how you can support.*

#### Q. Can you give a rough overview of the case folks are facing?

The Prairieland Defendants are facing potentially multiple life sentences due to a noise demo outside Prairieland ICE detention facility. The feds are claiming that fireworks were aimed at the facility, rather than as a show of noise to offer solidarity to those detained in the kidnapping warehouse. They are also claiming that an officer was shot, injured in a contested location, and that this was an "ambush" by an "antifa cell".

#### Q. Any ideas why so many folks are facing such steep charges?

The government is out to make an example of our comrades, using conspiratorial yarn to tie defendants, no matter how disparately, to each other to produce what they want to sell: an "antifa cell". They want to make people scared to protest, scared to resist ICE terrorism, scared to fight fascism. That's why the charges are so horrific.

#### Q. Much of the states supposed evidence hinges around zines that were confiscated in defendants homes. Does it feel like the government is targeting DIY publishing and infosharing as part of this case?

Yes, zines are being used as evidence of intent for crimes, zines that were not even written by our comrades but distributed across leftist circles all over. One defendant's entire charge is moving a box of zines feds are claiming is "evidence
