WITH INTENT TO HINDER THE ARREST OR PROSECUTION OF SETH SIKES OR BENJAMIN SONG, NAMELY COMMITTING OR CONSPIRING TO COMMIT AGGRAVATED ASSAULT WITH A DEADLY WEAPON ON A PUBLIC SERVANT OR TERRORISM OR HINDERING PROSECUTION OF TERRORISM OR SMUGGLING OF PERSONS, DID PROVIDE OR AID IN PROVIDING SETH SIKES OR BENJAMIN SONG WITH THE MEANS OF AVOIDING ARREST, OR PROVIDE OR AID IN PROVIDING SETH SIKES OR BENJAMIN SONG WITH THE MEANS OF EFFECTING ESCAPE, OR TAMPER WITH PHYSICAL EVIDENCE, NAMELY DIGITAL CHAT LOGS AND/OR DIGITAL GROUP IDENTIFYING INFORMATION, WHICH MIGHT AID IN THE DISCOVERY OR APPREHENSION OF SUSAN KENT OR LYNETTE SHARP OR SETH SIKES OR BENJAMIN SONG,

COUNT TWO: AND THE GRAND JURORS AFORESAID UPON THEIR OATHS DO FURTHER PRESENT IN AND TO SAID COURT THAT THE DEFENDANT, ON OR ABOUT JULY 05, 2025, AND BEFORE THE PRESENTMENT OF THIS INDICTMENT, IN JOHNSON COUNTY, TEXAS, DID THEN AND THERE KNOWING THAT AN INVESTIGATION WAS IN PROGRESS, NAMELY, THE FEDERAL BUREAU OF INVESTIGATION AND JOHNSON COUNTY SHERIFF'S OFFICE INVESTIGATION INTO TERRORISM, ALTER, DESTROY, OR CONCEAL A RECORD, DOCUMENT, OR DIGITAL EVIDENCE, NAMELY SIGNAL AND/OR DISCORD DIGITAL CHAT LOGS AND/OR DIGITAL GROUP IDENTIFYING INFORMATION, WITH INTENT TO IMPAIR ITS AVAILABILITY AS EVIDENCE IN THE INVESTIGATION,

Against the peace and dignity of the State.
