**MOTION FOR SPEEDY TRIAL**

TO THE HONORABLE JUDGE BOSWORTH:

Now comes Defendant Janette Goering to move the Court to afford Defendant her right to a speedy and public trial, and in support shows as follows:

**I.**

This action commenced with Defendant's arrest on October 21, 2025. No indictment has been filed. A pretrial application for a writ of habeas corpus seeking a reduction of the oppressive \$5,000,000.00 bail amount was denied on November 14, 2025, and Defendant remains confined pending trial. Yet, no trial date has been set.

**II.**

Defendant cannot afford this bail as set, and she has been and will continue to be subject to pretrial incarceration. Defendant has been and will continue to suffer much anxiety and concern regarding the outcome of the trial herein. And any undue delay will hamper Defendant's ability to present her case at trial.

**III.**

Accordingly, Defendant formally invokes her right to a speedy and public trial, which is guaranteed by the Sixth and Fourteenth Amendments to the United States Constitution; Article 1, § 10 of the Texas Constitution; and Article 1.05 of the Texas Code of Criminal Procedure.
