I.

Defendant is currently incarcerated in the Johnson County Law Enforcement Center and is being confined and restrained of his liberty by said excessive Bail Bond amount.

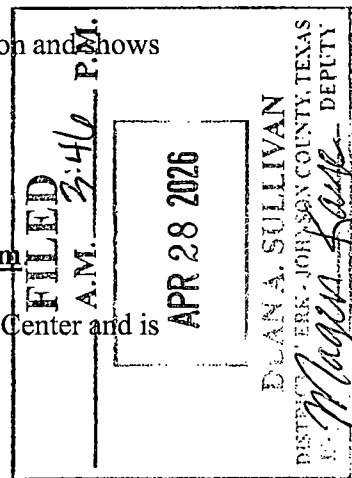
II.

request to reduce his Bail Bond amount to a reasonable amount so that he can post Bond and be released until trial date.
